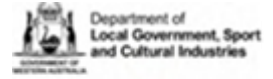

MANDATORY REQUIREMENTS & DISCLAIMER

To compete in the WAGA State Championships, every pilot in command must prior to commencement have satisfied the following mandatory pre-requisites:

- At least 25 hours solo in gliders.
- Silver C plus at least one 300km flight.
- Knowledge of GFA MOSP regarding the Rules of the Air.
- Current flying practice in competition and/or cross-country gliding as defined by the GFA.
- Current membership of GFA.
- Annual check flight valid for the duration of the competition.

Please ensure that you have the following in place to produce prior to the Comps:

- FAI Competition Licence or GPC
- Current Maintenance Release
- Current Parachute packing slip
- We may weigh gliders and enforce maximum flying weight.

I agree to abide by the competition rules (including any amendments) and all local rules.
I am aware that if my / our glider does not meet the airworthiness requirements of those rules, my entry may be rejected.

I agree to waive all claims against:

- The Gliding Federation of Australia
- The Narrogin Gliding Club
- Any West Australian Club affiliated with WAGA,
and
- Any person assisting in the organisation and running of the competition (including matters ancillary to the competition) for any personal or property damage whatsoever.
